TERMS OF ENROLLMENT

Gateway Academy relies on tuition to meet operating expenses. Therefore, it is essential that the income from tuition be assured. For this reason, I agree to pay the tuition and fees for the 2023 Summer Camp.

The Parent understands and agrees that the student's placement is not secured until the Enrollment Agreement and Camp Fee have been completed.

The Parent also understands and agrees that their student is considered *enrolled* upon submission of the completed enrollment forms with associated fees to the Admissions Office.

TUITION AND FEES

Tuition (6th -12th Grades): \$750 per week; \$1,500 per two week session; and \$3,000 for the 4 week Summer Session.

Empowerment Scholarship/State Tax Organization Recipients of (ESA) (STO) scholarships are able to use those funds for Summer Camp.

Discharge from Camp

Gateway Academy is very clear about accepting students who do not have behavioral issues, as noted in all of our printed materials. Any student that exhibits unacceptable behavior, as explained in depth in the Parent/Student Handbook, will be either suspended or expelled depending on the severity and/or frequency of the problem. The school reserves the right to discharge, at any time, any child or family, who, in the opinion of the Administration is not

benefiting from the instruction OR whose behavior is detrimental to the Warrior Summer Camp. The recommendation and observations of the Leadership Team, Therapists, and teachers are taken into consideration and withdrawal is not undertaken unless we can see that it is to the best advantage of the student, and/or the classroom. However, withdrawal may be recommended after any length of time, if it is ascertained that the student's or classroom's needs cannot be met in the environment provided by Gateway Academy. Discharge by the school does not relieve the Parent of the responsibility for payment of the above mentioned tuition and fees.

Financial Agreement:

I agree that in return for the Camp services provided to the student, I will pay the account of the student prior to each Summer Week Session. If the account is sent to any attorney for collection, I agree to pay reasonable attorney fees and collection expenses. The amount of the attorney's fee shall be established by the Court and not by a Jury in any court action. A delinquent account may be charged interest at the legal rate.

I understand that the School has the right to refuse enrollment, to refuse admittance to camp, if I am delinquent under this agreement unless all charges on the Student's account have been paid or a formal arrangement for payment has been made satisfactory to the Board of Directors of the School.

I have read the 2023 Warrior Summer Camp Enrollment Agreement. I have taken full opportunity to make all inquiries necessary to understand the policies, curriculum, and terms of tuition responsibilities of Gateway Academy. Upon signing, I agree to abide by the policies, both financial and otherwise, as stated in the handbook and enrollment forms.
